

# GREECE VISA REQUIREMENTS

## TOURISM

- **Schengen visa application form**
- **Valid Passport** (with 3 month's validity from the end of intended stay, must contain two empty pages)
- **Photocopy of Bio page**
- **Previous visas and immigration stamps** (from the current and 2 old passports)
- **Two passport photos** (**35mm x 40mm**, passport-size, white background, with the present, same image and likeness)
- **Airline Ticket Reservation** (we can provide)
- **Hotel booking confirmation** (we can provide)
- **Daily travel itinerary** (we can provide)
- **Travel Health Insurance** (Minimum coverage of **30,000 Euros**, must be recognized in all Schengen States, valid period of the insurance coverage must be for the duration of the intended stay)
- **If Single: Birth Certificate** (certified by the Philippine Statistics Authority (PSA))
- **If Married: Birth Certificate and Marriage Contract** (certified by the Philippine Statistics Authority (PSA))
- **For non-Filipino applicants** (Please present your **ACR, ICR valid** at least three months beyond the date of departure from the territory of the Schengen States (and 1 set of photocopies))
- **Proof of social security contributions, if relevant**
- **Copy of real estate property – title-deed, if relevant**

### For Employees:

- **Original Employment Certificate** with leave of absence (must include applicant's position, date hired, salary, date of return to work)
- **Personal Original Bank Certificate** (must be addressed to the Embassy)
- **Bank Statements, Bank Books** (including the movements of account in at least the last 6 months)
- **ITR**
- **Copy of Company ID** (back-to-back)
- **Copy of PRC/IBP ID** (*if professional*)

### For Self-Employed:

- **Proof of company registration issued by the Department of Trade Industry (DTI)/Securities Exchange Commission SEC registration of business**
- **Latest Income Tax Return**
- **Business Financial Statement**

### For pupil or student:

- **Proof of enrolment**
- **Certificate of leave absence if travelling during school year**

### Minors:

- If travelling alone or with only one parent: **written consent** of the non-travelling parent/legal guardian or **proof of sole custody** of the travelling parent or legal guardian.
- If the name of the father does not appear in the PSA issued birth certificate, **no consent is required.**
- **Copy of bio data page of parent(s)** or legal guardian's passport.
- Birth certificate certified by the Philippine Statistics Authority (PSA).
- If travelling alone: **Department of Social Welfare and Development (DSWD) clearance.**

### Family or friends visit:

- **Proof of sponsorship and/or proof of accommodation**
- **Proof of relationship, such as birth certificate, marriage certificate or photocopy of the biodata page of the sponsor's passport**

### Note:

- Please be advised all documents should be printed in A4 paper.
- Additional required documents may be asked to the applicant depending on the category of visa applying for.
